Publication

The accepted papers will be invited for presentation at the conference, and then considered for publication in a special issue of Journal of Economics and Development (Scopus-indexed).

The accepted papers will also have other chances to be published in a special ISI/Scopus journal issue to be announced later, tentatively scheduled in 2025.

Travel Arrangements

Limited travel support will be available. The travel costs of one author per paper may be covered.

Submission

Authors are requested to submit their **full papers in English** (formatted using MSWord with New Times Roman font, type size 12 with 1.5 line spacing and the length should not be more than 10,000 words inclusive of tables, figures, notes, references and appendices) via email <u>conference@neu.edu.vn</u> **no later than February 14,2025.**

Papers should include a description of the research background, methodology, data, results, and evidence-based policy recommendations. Please also provide the name, affiliation, position, and email of each author, and clearly indicate the corresponding author.

All papers must be original that has neither been published nor currently under review by any journal, conference, or outlet.
